#### **Activities Conducted:**

#### Ethnographic Workshop:

The workshop was organized from 8<sup>th</sup>-10<sup>th</sup> December 2014 at the Convention Centre & SSS-I, Jawaharlal Nehru University, New Delhi.

The objective of this course was to impart rigor and advanced skills in conducting qualitative research. Indian scholarship in academics, especially in the field of social sciences suffers due to lack of consistency in research methods. This restricts transformation of research in replicability and application; and limits wider dissemination through publication, especially in national/international journals of repute. Rigor in doing qualitative research mostly embedded in anthropological subdisciplines will enable young scholars from universities to update and refresh research skills, keeping in line with the realm of trans-disciplinarily, multidisciplinary and interdisciplinary approaches

#### A National Symposium:

Title: 'Breaking the Culture of Silence Against Child Sexual Abuse: Towards an Integrated Action Plan for Prevention'

Anthropos India Foundation in collaboration with Save Children Fund, CRY (Child Rights and You) and CSE (Center for Science and Environment) conducted a daylong national symposium titled 'Breaking the Culture of Silence Against Child Sexual Abuse: Towards an Integrated Action Plan for Prevention' on 22<sup>nd</sup> October 2016 organized at JNU, New Delhi. This symposium aimed to address the issue of CSA from a systems approach and position it within the public health framework. While trying to gather relevant solutions for the same, the symposium aimed to gather recommendations for future work and also suggest a way forward.







#### A National Seminar:

### 'National seminar on Indigenous Healing Practices among the Tribes: challenges in recognizing and mainstreaming'

The National seminar was organized in Jawaharlal Nehru University, New Delhi from 10<sup>th</sup> -11<sup>th</sup> February 2017. The seminar was organized to discuss and deliberate on the issues of ethno-medicine or indigenous medicines among scholars who have been engaged in this area of study. Dr. Sunita Reddy, Convener of the seminar welcomed research scholars & eminent personalities who have been working in the field of ethno-medicine & indigenous health practices and took forward the two-day long seminar.

The seminar was organized on five broad themes:

- I. Indigenous healing practices among the tribes,
- II. Challenges in integrating and mainstreaming tribal health knowledge,
- III. Intellectual property rights, bio prospecting and benefit sharing, and
- IV. Inter-disciplinary approach to research, and
- V. The way forward for policy and planning.

## 1. CARE, CURE, CATER -Healthcare Between Sympathy and Profit: Insights from Corporate Hospitals Accommodating Foreigners in Delhi

Dr. Hiedi Kasper Department of Geography, University of Zurich, Switzerland



This lecture talked about the increasing praxis of crossing national boundaries in the search for affordable medical treatment and the growth of medical tourism industry in India & elsewhere have been viewed as inherently intertwined with globalization, increasing ease in traveling and communicating around the globe as well as marketization and corporatization of healthcare. However, little has been said so far how these intertwinings unfold on the ground in the everyday practice of giving and receiving care. Therefore, the paper discusses how for-profit healthcare provision to foreigners unfolds

in corporate hospitals in Delhi NCR.

#### ${f 2}$ . Distinguished Guest Lectures- Relevance of Anthropology in Contemporary World

Prof. Vinay Kumar Srivastava Delhi University



A distinguished guest lecture series was organized by Anthropos India Foundation (AIF). Eminent Anthropologist Prof. Vinay Kumar Srivastava, University, delivered the second lecture. Dr. Arun P. Bali, former Director (IC) & Managing Editor ICSSR chaired the session. It talked about how Anthropology is understood as a study of the so-called non-western, simple, 'primitive' and non-conspicuous societies of the world. Though the branches of urban and industrial anthropology are progressing

fast, anthropologists' image as experts on 'primitive' societies continues. The development of science and technology, has led to greater power over environment and opportunities to enhance human capacity, though with a class character. The rise of totalitarian ideologies also defied many assumptions about future.

## **3.** ANTHROPOLOGICAL INSIGHTS FOR FOOD SECURITY AND CLIMATE CHANGE- issues of food security and sustainable development in the in the context of humanogenic climate change.

Prof. Joan P Mencher
Professor of Anthropology from the Graduate Center and Lehman College of the City University of New York (retd).



The lecture was about how anthropologists have an essential role in addressing the issues of food security and sustainable development in the context of humanogenic climate change. Studies of small-scale sustainable agriculture show the many ways in which small farmers have been dealing with food security issues and coping with climate stress. The successes of SRI/SCI, a new set of agricultural strategies, show a potential to reverse the damage caused by decades of for-profit agriculture, and provide a meaningful living for millions of Indian farm

families. Anthropologists can be important advocates for farmers.

#### 4. What Constitutes Evidence in Human Rights Based Approach to Health

Prof. Maya Unnithan Institute of Development Studies, Sussex University



The impact of human rights interventions on health outcomes is complex, multiple, and difficult to ascertain in the conventional sense of cause and effect. Existing approaches based on probable conclusions from evidence are limited in their ability to capture the impact of rights based transformation in health. This talk focus on plausible conclusions from evidence

enables policy makers and researchers to take into account the effects of a co-occurrence of multiple factors connected with human rights, located in "context" ad power, focusing on lived experiences of human rights –based interventions in maternal and reproductive health care and addressing the methodological challenges.
